Open Awards offers a high-quality accreditation and certification service for education and training. We are committed to offering:



We provide vocational qualifications from Entry Level to Level 6 as well as End Point Assessments on a number of Apprenticeship Standards and the prestigious Access to Higher Education diploma.

We're looking for people with a passion for skills and helping people achieve their potential and would be particularly interested in people with experience in Higher Education, Apprenticeships and/or experience of delivery in Wales. A significant amount of our work is undertaken within the health and care sector and would welcome applicants who can share their knowledge and experience in this area.
