



## Privacy Notice - Learners

This privacy notice is issued by Open Awards to inform you how we will use learners' personal information. For the purposes of the Data Protection Act 1998/General Data Protection Regulation (GDPR), Open Awards is the data controller for personal information processed by the organization.

As an Awarding Organisation we have a responsibility under the Data Protection Act to ensure that learners are informed of how their information is processed and shared.

**A copy of this Privacy Notice should be made available to all learners so that they understand what personal information you share with Open Awards and how we use it and who we share it with.**

### Who are Open Awards?

Open Awards is an Awarding Organisation regulated by Ofqual and an Access Validating Agency approved by the Quality Assurance Agency for Higher Education (QAA). We also approve a range of unregulated, or 'quality endorsed', courses which are required to meet the same set of quality standards as with all our provision. ### What personal learner information does Open Awards collect?

Open Awards collects and processes personal learner information for the purpose of registering learners and awarding learner achievements, to exercise its functions and meet its responsibilities, both statutory and otherwise. This is normally submitted to Open Awards through the Open Awards secure portal. Only pre-approved users have access to the portal by means of a secure login which is provided by Open Awards and are bound by the Terms and Conditions of the Open Awards portal.

The personal information collected that can be used to identify you includes, but is not limited to name, date of birth, gender, ethnicity, disability, postcode, as well as achievement and course data.

Whilst we endeavor to collect only that data for which there is a legal or sound business requirement, and to ensure the integrity of the data, we strongly encourage customers to contact us if you believe any data to be incorrect.

## Children's Privacy

Open Awards does not knowingly register or collect personally identifiable information from anyone under the age of 13 ("Children"). If you, or a parent or guardian, has cause to believe that a child has provided us with personal information, please contact us immediately. If we become aware that we have collected personal information from a child under age 13 without verification of parental consent, we will take steps to erase that information from our servers.

## Who do we share data with?

Open Awards, as part of their legitimate business functions, share this data with our regulators and may also share it with a small number of other organisations with whom we share a business partnership in the interest of the learner. These organisations include:

Unless otherwise stated, data is normally shared and processed as anonymised data. However there may be situations, such as an investigation or complaint, when Open Awards are required to process or share individual personal details due to a legitimate business reason. In these instances, Open Awards will share only those details which

are necessary to the case and will endeavour to maintain the security of this information.

You register learners with their Unique Learner Number (ULN) as part of the registration process and Open Awards validate this through a secure link with the Learner Records Service (LRS) during the initial registration. If any ULNs are invalid we will notify you of this using our secure portal to advise you of the actions we require you to take to rectify the error.

Upon achievement of Qualifications and/or Qualification units, the achievement details of learners will be passed to The Learning Records Service for updating their Personal Learning Record (PLR). This is done through a secure link from the Open Awards database to the LRS database. The PLR is a source of information to support Learners in their decision making in relation to further study, employment or skills development and we will only send achievement data to the Personal Learner Record (PLR) if a learner has a valid ULN.

Learners may choose not to share their PLR data and can opt-out by contacting the LRS directly. They will need to provide some personal details to confirm their identity which may include their Unique Learner Number (ULN) if known.

## **Where do we store personal data?**

All personal information provided to us is stored on our secure servers located in the UK, or on the secure servers of sub-contractors that we have engaged to provide services on our behalf.

The security of personal information is vitally important to us, but no method of transmission over the Internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect personal information, we cannot guarantee its absolute security

## **Access to your information and correction**

Open Awards tries to meet the highest standards when collecting and using personal information. For this reason, we take any complaints we receive about this very seriously. We encourage people to bring it to our attention if they think that our collection or use of information is incorrect, unfair, misleading or inappropriate.

You have the right to request a copy of the personal information that we hold about you by making a 'Subject Access Request' under the Data Protection Act 1998. If we do hold information about you we will:

- give you a description of it;
- tell you why we are holding it;
- tell you who it could be disclosed to; and
- let you have a copy of the information in a clear format
