#### **Role Profile**

This occupation is found in horticulture grounds maintenance, landscaping, parks, greenspaces and gardens (historic, botanic, destination and estate).

They might be working for a charity, a consultancy, governmental organisation, private estate/client or commercial contractor. The broad purpose of the occupation is to develop, build and manage parks, gardens, greenspaces and grounds (e.g. business parks, schools, retail sites etc.).

# On-programme Stage

Full-time apprentices will typically spend 36 months on-programme (before gateway) training to meet the KSBs as outlined in the occupational standard. All apprentices must spend a minimum of 12 months on-programme. All apprentices must spend a minimum of 20% of on-programme time undertaking off-the-job training.


### **Completion and Certification**

The result from each assessment method is combined to decide the overall apprenticeship grade. The EPA period is a maximum of 9
