

Recommended Assessment Method Summary

Learners will either complete a portfolio of evidence set and marked by the education provider and externally quality assured by Open Awards. Or may complete an online learning programme and a summative assessment.

Candidates must provide sufficient evidence that they have the required knowledge, skills and understanding of the assessment criteria and that it is their own work.

This qualification has been developed in partnership with the Institute of Explosives Engineers (IExpE) who are the recommended delivery partner. This qualification combines their existing Badge of Excellence Programmes of Explosives Safety and Handling and Pyrotechnics in Training. These programme, associated assessment plans and risk management has been externally quality assured by Open Awards to ensure they meet the full requirements of the qualification.

IExpE aims to be the organisation that establishes and oversees National Occupational Standards for the Explosives Industry and to provide a forum that enables and promotes consultation between individuals, professional private organisations, government departments and armed forces experts within the explosives industry.

Open Awards and The Institute of Explosives Engineers

The new qualification will set the basic safety and knowledge requirements for anyone wishing to enter the Sector.

Where the IExpE approves other organisations to deliver training on their behalf, this will be managed through a sub-contracting arrangement directly with them. In this case, centres are not required to go through centre recognition with Open Awards. Learner registration, internal quality assurance of the delivery and assessment remains the responsibility of the IExpE; and external quality assurance of the delivery, assessment and award of qualifications remains the responsibility of Open Awards.

Please be aware that approval from IExpE to use this qualification and associated training materials does not constitute approval from Open Awards to deliver other regulated qualifications in their own right.

Delivering this Qualification

Becoming a Centre

Registering Learners

Open Awards require all learners to be registered within the timescales below:

Short courses (15 weeks or less) within 25 working days of the course start date. Full year long courses (over 15 weeks) within 60 working days of the course start date.

Learners will need to be registered via the Open Awards portal.

Quality Assurance and Standardisation

Delivery of this qualification must be done so in accordance with Ofqual regulatory guidelines and in line with Open Awards' quality assurance processes. Template forms and guidance documents are available via the Open Awards portal.

Centre Staff Requirements

It is expected that centres will have occupationally competent staff with relevant sector experience for their role in the delivery of the units/qualifications being offered.

For the delivery and assessment of this qualification, it is expected that staff have a qualification at the level or higher in a related subject or to be able to demonstrate recent and relevant experience of working within this field; and have up-to-date working knowledge and experience of best practice in assessment and quality assurance.

Centres are responsible for ensuring that their staff are occupationally competent and have access to appropriate training and support. They are also responsible for notifying Open Awards of staff changes.

Centre's delivering this qualification through the IExpE do not need to become an Open Awards site as the assessment and internal quality assurance procedures
