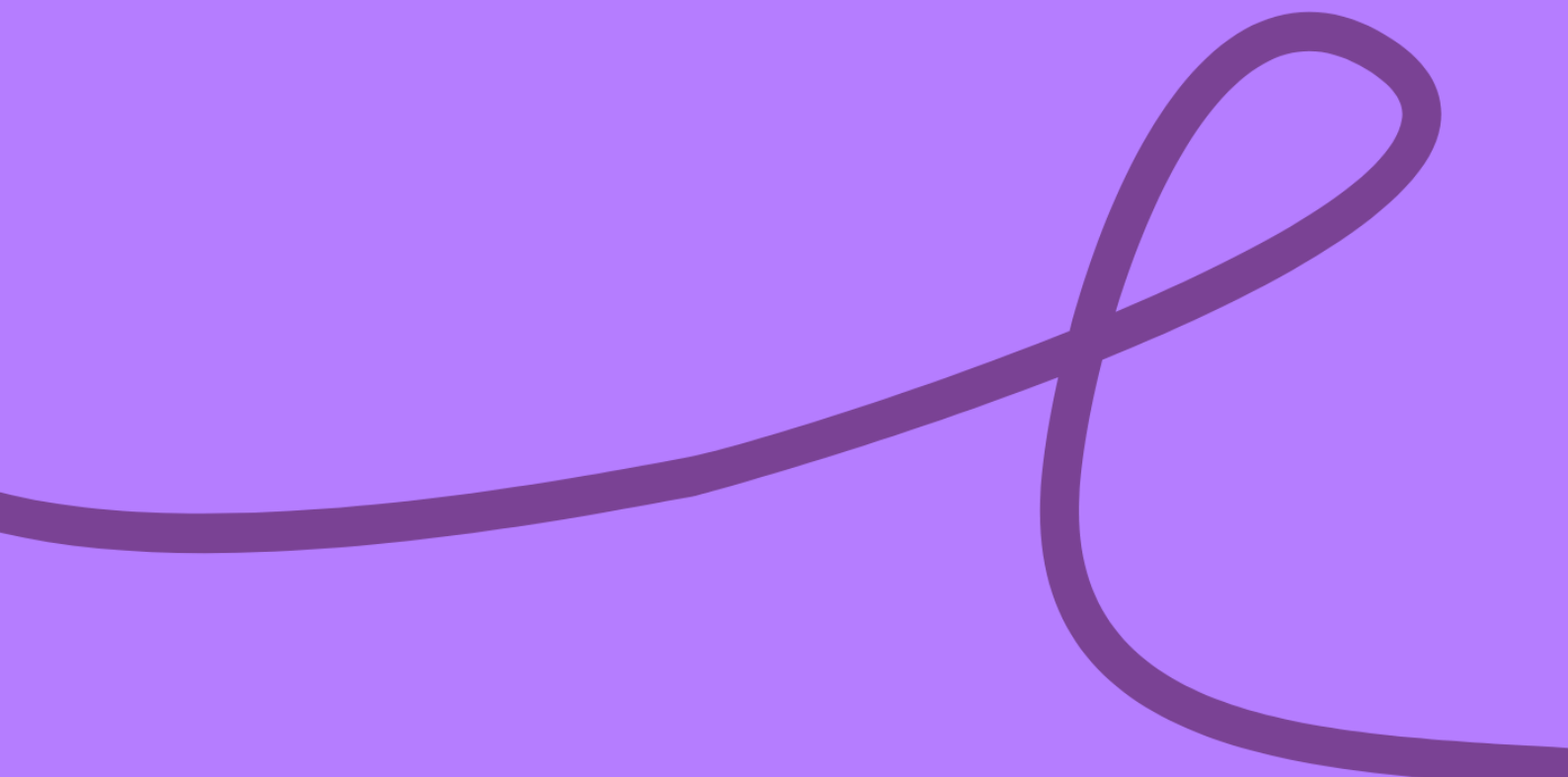

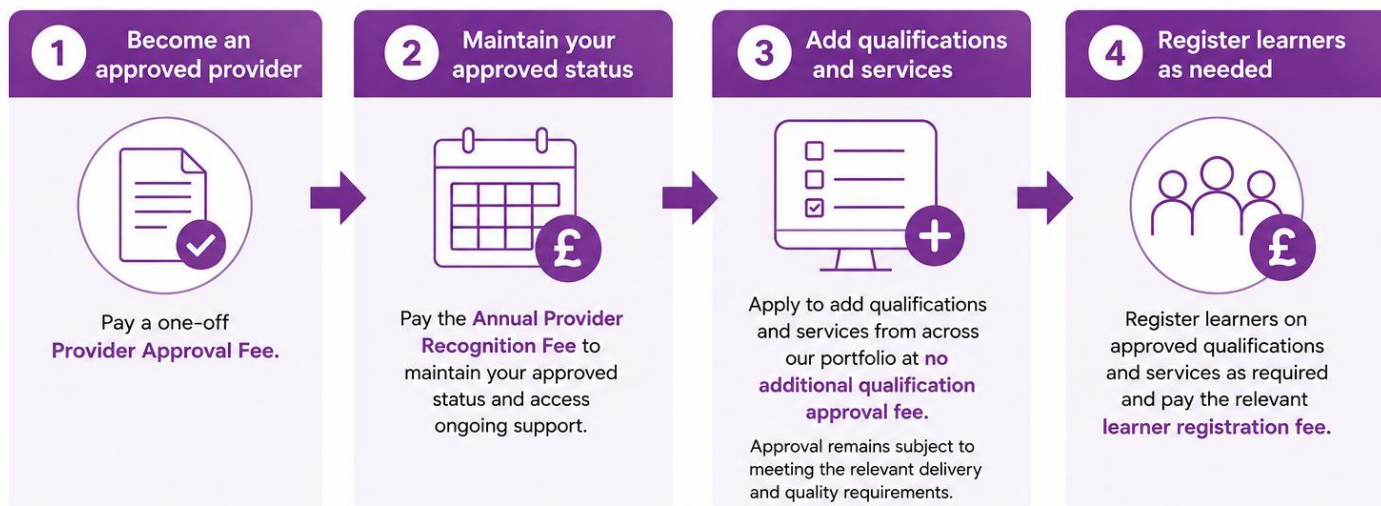

Introduction

A straightforward and flexible pricing model



Once your organisation is approved by Open Awards, you can apply to deliver qualifications and services from across our portfolio without paying additional qualification approval fees.

You pay a one-off Provider Approval Fee, followed by an Annual Provider Recognition Fee to maintain your approved status.

There is no additional fee for qualification approval, but approval to deliver each qualification may still be required.

You can then register learners on approved qualifications and programmes as required, paying the relevant registration fee for each learner.

There is:

- no additional qualification approval fee
- no minimum number of learners
- no minimum annual registration spend
- no requirement to register learners on every qualification you are approved to deliver.

This gives providers the flexibility to respond to learner, employer and local needs without committing to fixed registration volumes.

To deliver Open Awards qualifications, units or programmes, your organisation must first become an approved Open Awards provider.

Once approved, providers will be invoiced for the **Annual Provider Recognition Fee**, which is pro-rated according to the number of complete months remaining in the academic year (1st August – 31st July).

Annual Provider Recognition Fee

All approved providers pay an annual recognition fee to maintain their approved status.

The fee provides access to ongoing quality assurance and curriculum support, including:

- online quality and compliance training
- curriculum planning guidance
- advice and support from a dedicated Quality and Standards Adviser
- continued access to provider resources and updates.

Qualification Unit Course Registrations

Open Awards offers a flexible Unit Course model, enabling providers to package individual units into a bespoke course. Unit Courses can be created using either:

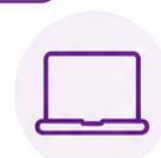

Open Awards continues to provide independent End-point Assessment for the apprenticeship Standards listed below during the transition period to new assessment plans.

Training providers and employers are responsible for selecting an approved assessment organisation for their apprentices. Where Open Awards is selected, the training provider must complete the required service request and enter into a Service Level Agreement with us.

There is no charge for completing the service request or entering into the Service Level Agreement.

The End-point Assessment fee includes:

- apprentice registration
- delivery of the required assessment methods
- quality assurance of assessment decisions.

Providers are invoiced:

- 5% of the assessment fee at registration; and
- 95% when the apprentice reaches gateway.

Apprenticeship Assessment

Under the reformed model, assessment is incorporated into the apprenticeship programme through a qualification model rather than delivered as a separate End-point Assessment service. Open Awards is developing apprenticeship assessments that align with the requirements of each published assessment plan.

For every apprenticeship Standard, Open Awards will design an assessment approach that clearly identifies:

- the assessment components that may be delivered by the training provider as an Approved Open Awards Provider; and
- the assessment components that must be delivered independently by Open Awards.

This gives providers the flexibility to choose the delivery model that best meets their expertise, capacity and business needs.
